- 6. Committee Reports:
 - A. Volkssport Committee- Diane Prost, POC
 - Future Traditional Events
 - Nashville, IL Guided Traditional Event August 17, 2019. Diane recently attended the Chamber of Commerce meeting Diane Prost, POC. Our walk is sanctioned.
 - Chester, IL Guided Traditional Event September 7, 2019. Vickie Ridgeway, POC. Vickie has been in contact with the Parade Chairman. Vickie and Diane Prost went to visit the town, met with the Parade Committee chairmen at the Spinach Can Collectibles store, we introduced ourselves to City officials; and toured the town, taking in the sights of the many Popeye characters seen on the route. Note: Popeye, himself, is not on the route, but by the river at a welcome site. Beautiful place to drive to on your way to or from the walk, with lots of history bits about the town, Also, noted, this will be their 40th Anniversary. Banner?  - Do we want a patch or coin for the commemoration also?
- AVA Bylaw Amendments There are several proposals that will be voted on at the convention in Albany. Leonard Wojtysiak will discuss each proposal and the pros/cons as it pertains to the Illinois Trekkers. Members present will vote on each item and that information will be forwarded to Trudy Duffman so she can vote in accordance with the Illinois Trekkers votes. (copy of original proposal will be attached to minutes in permanent record).
 - 1) **Club Votes YES**. Change to calendar year vs fiscal year. Diane Prost made the motion. Vickie Ridgeway 2nd. Motion passed.
 - 2) 7.1. **Club Votes NO**. Add up to 3 "at large members" to the Executive Board. Discussion: Increased cost to transport/fly to meetings and company having trouble making ends meet now. Diane Prost made the motion. Dee Wojtysiak 2nd. Motion passed.
 - **If 7.1 passes** at the convention, the AVA Executive Director will be able to nominate his own staff who will report directly to the Ex. Dir. and not to the Ex Board. The rest of these pertain to this clause...
 - 3) 10.1. Club Votes NO. Executive Director will have the authorization to establish his own committee. Dee Wojtysiak made the motion. Vickie Ridgeway 2nd. Motion passed.
 - 4) 10.2. Club Votes NO. Members of Executive Committee would report directly to Executive Director and not to the Executive Board. Diane Prost made the motion. Dee Wojtysiak 2nd. Motion passed.
 - 5) 10.3. Club Votes YES. Consolidate and Reduce Standing Committees. (May add temporary committees.) Dee Wojtysiak made the motion. Diane Prost 2nd. Motion passed.
 - 6) 10.5. **Club Votes NO**. Executive Director will have control of the committees that he/she creates, and members shall report to the executive director and not

the Executive Board. More financial burden on AVA. Diane Prost made the motion. Dee Wojtysiak 2nd. Motion passed.

 - o No mention was made to change the walking fees.
