ONLINE START BOXES [OSB]

Have you tried the OSB yet? Many of the local walks now have OSB capabilities. Check them out!!!

Leonard Wojtysiak has been terribly busy tackling the task of creating OSB for Trekker events that have complicated start locations. Both the Marvville YMCA (walk & bike) and the Edwardsville YMCA (walk & swim) have restrictions on access to the facility. The start binders for all four events have been in possession of the POC Vickie Ridgeway. She and Leonard worked together to develop OSB for these events. Again, to sign up through the OSB, you must create a personal account at my.ava.org. You will be asked to establish a credit card on this account and add money in it to be eligible to sign up for walks. This is applicable for all OSB events throughout the United States. Numerous clubs have created OSB for their events due to the restrictions placed on start locations by the COVID pandemic. Please note that the Gateway Milers have their events with OSB options as does the Saint Louis Walkers (formerly the St Louis-Stuttgart Club). Thank you, Leonard.

Leonard's Walking Story

My story started in 1983 when I was assigned to Ramstein AFB in Germany. After a couple of weeks getting to know my fellow office workers they asked if I would like to join them on a volksmarch. Having nothing planned for that Saturday I agreed. Thought it might be a good way to see some of Germany.

We would carpool to the walk and do the 10K together. Over there I might see an old castle or a World War 1 bunker or a World War 2 item around one corner or another. The forest had forest masters, so the woods were like our groomed lawns. Plus, there would be 2 or 3 lunch choices to pick from after the walk, inexpensive and tasted great. I was hooked!

I started jogging the walks and before I know it, I was doing 20K. Not long until I was doing two 20Ks on Saturday and then 2 more on Sunday so I was able to see a lot of that area. Missed not walking with my friends but I could jog the 20K and usually it ended on the 10K trail, so I could catch them at the end, to walk with them for the final K or so. Isn't it great to be young or at least younger?

After returning to the states in 1985, I started doing the walks in this area when I had time. It is fun to look back at my logbooks and see where some years I did over 100 walks and another year maybe only 4. (Was rebuilding my home that year.)

A funny side note, in 1980 I remember seeing Tom and Betty Boyd plus others with a table outside the Base Exchange. That was the year about 20 of them were starting the Illinois Trekkers Club. Of course, I did not know what it was all about, so I just passed by the table. If I had known, I might have been a charter member of the club.

After a lot of years, I realized that if I wanted the walks to continue, I had better chip in and help put the walks on, so I joined the Illinois Trekkers. Almost immediately I took over the treasurer's job and have held just about every job in our club plus state and national positions as well over the years.

Thank you for letting me think back over the many years of fun, remembering many walks, thinking about all the neat people I have had the chance to meet walking, plus all the good food that was eaten before, during, and/or after the walks. By the way, I met my future wife while doing our walks. She is my current wife of 17 years. Saturday, May 1, 2021, was a beautiful day for a walk in Highland, Illinois. 53 people walked one or both 5k's in Highland. We had several walkers from Highland and gained two new members!

In addition to the walk Bob Buzolich, Regional Director, awarded Scott Billhartz (Treasurer of the Lebanon Cedar Cruisers) a 35th Anniversary Award, a Meritorious Award to Bill Malina, President of Lebanon Cedar Cruisers for 25 years, and a Commendation Award to Scott. The Lebanon Cedar Cruisers disbanded late last year due to Bill's health. Highland was one of the Lebanon Cedar Cruisers signature traditional walks.

Thank you to all the Illinois Trekkers that volunteered their time for the Highland Walk. Thank you to all those who came out to enjoy the beautiful day in Highland.
